A prior period adjustment was made for an an error in recording a 2015 corporate pledge receivable. During the fiscal year ended December 31, 2015, a pledge revenue and receivable was recorded in the amount of \$655,000. It was determined during a review of the timing of pledge receipts that a grant request of this amount was not made for the revenue recognized from the 2015/2016 United Way campaign and that any subsequent receipt of a pledge in that amount during the fiscal year ended December 31, 2016 was attributable to the 2016/2017 United Way campaign. To correct the error in the pledges receivable outstanding and the revenue recognized in the prior period, an adjustment was made to reduce pledges receivable and net assets in the full amount of \$655,000.
